#### **ITEM #1**

##### **TREASURER'S REPORT:**

#### **ITEM #2**

##### **REDUCING THE SPEED FROM 50 KPH TO 40 KPH:**

Barbara has drafted a letter to MOTT asking to reduce the speed from 50 KMH to 40 KMH within San Pareil.

- Barbara has also asked for an update on Phase Two of the Plummer Road and Hwy 19A Intersection.
- Asking to move the speed sign on Hwy 19A showing 50 KMH back towards the Log Cabin.
- Replace the white Dividing Posts entering San Pareil.
- Install a sign along Plummer Road, Expect Deer On Our Roads
- Consider asking if a stop sign instead of a yield sign would help improve the intersection coming off 19A.

The entire board supports the drafted letter and approved sending it to MOTT.

#### **ITEM #3**

##### **POSAC MEETING (Parks and Open Space Advisory Committee) within the RDN:**

The POSAC meeting was held on Monday, February 2, 2026.

We have been advised of the following:

Various times over this year the grass field will be upgraded.

Adding the new amenities is tentatively scheduled to start in the Spring of 2026 with a probable completion date in Fall 2026.

We will contact RDN Park Services to inquire if there will be any disruption to park use/additional traffic on Maple Lane. When we are notified of changes to park availability we will let the community know via a San Pareil Facebook post.

Spora will plan an Opening Park Event once we become aware of the completion date.

##### **COMMEMORATIVE BENCH FOR CLARKE GOURLAY, FORMER RDN AREA G DIRECTOR:**

Barbara has been advised by Rick Daykin, RDN Park Manager that the funds raised in the amount of \$2100.00 will be sufficient for the Commemorative Bench for Clarke Gourlay. The funds in the amount of \$1200.00 had previously been donated by the residents of San Pareil. SPORA contributed \$900.00 which had been previously raised through San Pareil Garage Sales, held at the entrance to Maple Lane Park over the past two years.

Clarke Gourlay's son Ray will prepare the wording for the bronze plaque to be placed on the Commemorative Bench.
